

## **PBAM 2023-24 Player Waiver and Team Roster Form, Release of Liability and Indemnification Agreement**

### **(ADULT DIVISION – PABCOMS)**

I, the undersigned, as the player named below, do hereby voluntarily participate as a member of the PBAM (Philippine Basketball Association of Montreal).

I understand that there are certain risks of damages and injuries, including death, inherent in the practice and physical play of basketball. I understand that the very nature of the game of basketball is hazardous and risky but I am willing to assume these risks which include but are not limited to those hazards associated to weather conditions, travel, playing conditions, equipment and other participants, the acts of running, jumping, stretching, sliding, diving, and collisions with other players and with stationary objects, all of which can cause serious injury or death to me and to other players. Further, I agree that in consideration for my right to participate as a member of the team designated below and in consideration for permission to play with the team for the PBAM against other teams in the league.

1. I do voluntarily elect to accept and solely assume all risks of injury incurred while practicing or playing as a member of the team so designated,

2. In addition to giving my full consent of participation, I do hereby release, discharge and agree not to sue the team management staff, the PBAM League Officers, the practice facility management, the tournament host management- its officers, agents, servants, its association and league designated below, the Team Management staff, or any person or entity connected with the PBAM for any claim, damages, costs including attorney fees, or cause of action which I have or may in the future have as a result of injuries or damages sustained or incurred from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released.

I hereby certify that I am fully capable of participating in the designated sport and that I am healthy and have no physical or mental disabilities or infirmities that would restrict full participation in these activities, except as made known to coaches and officials of the team and league. I further agree that I shall hold harmless and fully indemnify the parties hereby released from any and all claims, damages, costs including attorney fees, and causes of action which may arise even if the damages, injuries or death are caused in whole or in part by any of the persons or entities hereby released.

**Severability:** The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the laws of the Province of Quebec.
